Safe Bag signs a contract with Katowice-Pyrzowice International Airport in Poland

Milan – 19 December 2017 - Safe Bag S.p.A., one of the leading companies worldwide in the protection and tracing of luggage for airport passengers, would like to announce that it has signed a temporary contract to supply its integrated range of services for travellers at **Katowice-Pyrzowice International Airport in Poland**.

Katowice-Pyrzowice Airport, where there are currently no luggage wrapping and protection services available, is the third most important airport in Poland, used by a total of approximately 3.2 million passengers in 2016, a figure that has witnessed a 21.1% increase in 2017. It has two terminals, one for national arrivals and departures and the other for incoming and outgoing international flights.

According to the contract signed, the activities will be launched at the beginning of May 2018 on a provisional basis until the end of October 2018, to test the response to the service in the two terminals with a view to considering a long-term partnership.

“Since we entered Warsaw Airport on a permanent basis last May, we have seen a growing interest in our integrated range of services on the part of other Polish airports – states **Alessandro Notari, CEO of Safe Bag** – the Katowice contract – continues **Notari** – is a practical example of a modular partnership designed to bring benefits for both parties involved”.

The company has been listed on the Italian Stock Exchange Borsa Italiana –AIM segment – since September 2013.

Safe Bag, with headquarters in Gallarate (VA), has around 400 collaborators at global level, with around 2 million customers, and is present in the airports of Italy, France, Portugal, Switzerland, USA, Canada, Poland and Brazil with around 100 points of sale.
