### **Safe Bag comes first in the bid to provide “luggage wrapping” services at Venice “Marco Polo” airport.**

*Milan, 28 June 2017.* Safe Bag S.p.A. (AIM Italia - Ticket SB), one of the leading companies worldwide in the protection and tracing of luggage for airport passengers, would like to announce that the bids put forward in relation to the sub-tender for areas designated for “luggage wrapping” at Marco Polo, Venice, airport were studied and analysed in an open session yesterday, 27 June 2017.

The analysis procedure entailed the division of the areas subject to the bid into three different “lots” comprising 6 points of sale, with the possibility of each contender being assigned one or more lots. As a result of the above study, Safe Bag was placed:

- **first in the overall results regarding Lot A (thanks to the sum of points regarding the technical and economic offer);**
- **first in the overall results regarding Lot B (thanks to the sum of points regarding the technical and economic offer);**

With reference to Lot C, we wish to clarify that none of the operators put forward a bid.

**The above-mentioned classification was made possible thanks to the wide gap between Safe Bag’s technical offer and that of the other participants: achieving more than twice the number of points of the runner up.**

Following the positive outcome of the study and analysis of the bids, details of the contract, which will run for 5 years as from next July, will be defined as set out in the tender.

Venice airport is the fourth largest in Italy with nearly 9.7 million passengers in 2016 and has registered a 6.6% growth in the first 5 months of 2017 compared to the same period last year.



**Safe Bag**, company founded by Rudolph Gentile in 1997 and led by the same, together with CEO Alessandro Notari, is one of the leading companies worldwide in the protection and tracing of luggage for airport passengers, offering an integrated portfolio of solutions designed to ensure passenger safety and comfort: bag wrapping; tracing; refund in case of loss or damage; travel accessories and products.

It has been listed in the Italian Stock Exchange since September 2013 in the AIM segment.

Safe Bag, with registered office in Gallarate (VA), has a payroll of approximately 400 workers located worldwide, serves about 2 million customers per year and is present in airports in Italy, France, Portugal, Switzerland, USA, Canada and Poland in about 80 points of sale.

The Group closed 2016 with a turnover of approximately 26.5 million euro.
